

Reservation Policy:

All of the following reservations are only available to candidates who are residents of Maharashtra State and meet the requirements set forward from time to time by the relevant authorities.

(A) Reservation for Candidates in the Backward Class category:

The percentage of seats reserved for Maharashtra candidates under the CAP is known as the reservation percentage.

B) Reserved for sons and daughters of Defence Department employees:

Children of ex-service people are eligible for five percent (5%) of the total sanctioned intake of an institute, up to a maximum of five (5) seats in any institute coming under CAP.

A) Reservation for Persons with Disability Candidate:

Five percent (5%) seats of total sanctioned intake of all the Institutions under CAP shall be reserved for Candidates having minimum 40% benchmark disability.

B) Reservation for Economically weaker section (EWS) candidate:

10% seats shall be reserved for EWS candidate. The Competent Authority will use CAP to fill these positions in accordance with the government's continuously declared policies. These seats will be allocated in excess of the authorized number.

C) Reservation for Tuition Fee Waiver Scheme (TFWS) Candidate:

5% seats shall be reserved for TFWS candidates. These seats shall be filled by the Competent Authority through CAP as per the policies of the Government declared from time to time. These seats shall be over & above the sanctioned intake.

D) Reservations for Orphan Candidates –

One percent (1%) seats of CAP Seats (excluding Minority institutions, All India Seats, if any) shall be reserved for Orphan Candidates.

E) Reservation for Female candidates:

30% seats shall be reserved for female candidates. There shall be no reservation for Female candidates under Defence, Persons with Disability and Orphan categories.
